PRESENÇA: Presentes acionistas representando mais de 55,6% (cinquenta e cinco vírgula seis por cento) do capital social votante e total da Companhia, conforme se verifica (i) pelas assinaturas no “Livro de Presença de Acionistas” e (ii) pelos boletins de voto a distância válidos recebidos por meio da Central Depositária da BM&FBOVESPA ou diretamente pela Companhia, nos termos da regulamentação da CVM. Presentes, ainda, integrantes da Administração da Companhia e a Sra. Kátia Sayuri T. Kam, representante da Ernst & Young Auditores Independentes.

ORDEM DO DIA: (1) Tomar as contas dos administradores, examinar, discutir e votar as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2015; (2) Deliberar sobre a destinação do lucro líquido do exercício social encerrado em 31/12/2015; (3) Eleger membro para compor o Conselho de Administração; e (4) Fixar a remuneração global dos membros do Conselho de Administração e da Diretoria para o exercício de 2016.

DELIBERAÇÕES: Após a leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, consoante o parágrafo 4º do art. 21-W da Instrução CVM nº 481/2009, foram tomadas, com a abstenção dos legalmente impedidos, as seguintes deliberações, havendo-se autorizado a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76:

(1) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 92,93% de votos a favor, representados por 923.460.685 ações; 0,00% de votos contrários; e 7,07% de abstenções, representadas por 70.292.683 ações, as contas dos administradores e as Demonstrações Financeiras relativas ao exercício social encerrado em 31/12/2015, acompanhadas das Notas Explicativas e do parecer da Ernst & Young Auditores Independentes.

(2) Aprovar, por unanimidade dos acionistas presentes, tendo sido computados 99,99889% de votos a favor, representados por 993.742.317; 0,00% de votos contrários; e 0,00111% de abstenções, representadas por 11.051 ações, a proposta de destinação do lucro líquido do exercício social encerrado em 31/12/2015, correspondente a R\$2.202.238.045,10, à conta de dividendos, nos seguintes termos:

(i) R\$1.242.614.000,00 à conta de dividendos obrigatórios, montante este que já foi distribuído aos acionistas por meio de dividendos intermediários e juros sobre capital próprio relativos ao exercício de 2015, no valor de R\$223.581.000,00 e R\$1.019.033.000,00, respectivamente; e

(ii) R\$959.624.045,10 para constituição da reserva estatutária para investimentos e composição dos fundos e mecanismos de salvaguarda da Companhia.

(3) Aprovar, por maioria dos acionistas presentes, tendo sido computados 97,48% de votos a favor, representados por 968.840.438 ações; 2,02% de votos contrários, representados por 20.011.720 ações; e 0,49% de abstenções, representadas por 4.901.210 ações, a eleição, nos termos do Estatuto Social, do Sr. **LAÉRCIO JOSÉ DE LUCENA COSENTINO**, brasileiro, casado, engenheiro elétrico, portador da Cédula de Identidade RG nº 8.347.779-SSP/SP, inscrito no CPF/MF sob o nº 032.737.678-39, domiciliado na Cidade de São Paulo, Estado de São Paulo, na Avenida Braz Leme, nº 1.631, 2º andar, para compor o Conselho de Administração da Companhia na qualidade de Conselheiro Independente, cumprindo mandato até a Assembleia Geral Ordinária que aprovar as demonstrações financeiras do exercício a se encerrar em 31/12/2016.

A posse do membro do Conselho de Administração ora eleito formaliza-se mediante a apresentação: (i) do respectivo termo de posse, lavrado em livro próprio, contendo as declarações em atendimento à lei e à regulamentação em vigor; (ii) da declaração de desimpedimento, para os fins do Artigo 147 da Lei nº 6.404/76 e do Artigo 2º da Instrução CVM nº 367/02; e (iii) da declaração dos valores mobiliários por ele detidos de emissão da Companhia e de suas sociedades controladas ou do mesmo grupo, nos termos do Artigo 157 da Lei nº 6.404/76.

(4) Aprovar, por maioria dos acionistas presentes, tendo sido computados 97% de votos a favor, representados por 964.124.710 ações; 2,27% de votos contrários, representados por

22.407.901 ações; e 0,73% de abstenções, representadas por 7.220.757 ações, a fixação da remuneração global anual da administração para o corrente exercício, no valor de até R\$ 9.074.000,00 para o Conselho de Administração e de até R\$ 40.153.000,00 para a Diretoria.

ENCERRAMENTO: Nada mais havendo a tratar, a presente ata foi lavrada, e, depois de lida e aprovada, assinada pelos presentes. São Paulo, 18 de abril de 2016.
